3.2 Secretariat

APIA and APNIC have agreed on a new MoU with effect from 1st January 2013. APNIC will now operate the Secretariat for APIA for a period of two (2) years.

Ms. Molly Cheam will continue in her role as Executive Secretary for APIA.

The Financial arrangement for Secretariat services is that APIA will pay APNIC USD50K per year via:

- Giving APNIC the status of Premium Member of APIA for the duration of this agreement (and waiving the membership fee valued at USD10K per year)
- Waiving the financial contribution, which would otherwise be made by APNIC to APRICOT (valued at USD4oK per year)

The MoU will be made available on APIA's website in a couple of days when it is officially signed. Meanwhile, Secretariat can still be contacted at apia-sec@apia.org

3.3 Membership

In year 2012, APIA had forty one (41) members comprising:

- One (1) Premium Organization
- Thirteen (12) Non for Profit Organizations
- Forty seven (28) Individual Members

As at 31st December 2012, one (1) Premium, twelve (12) Not for Profit and twenty-eight (28) Individuals have renewed their membership for year 2013. APIA Membership list is available on its website.

3.4 APIA Activities

APIA maintained its regular activities as follows:

- APIA joined APNIC & DotAsia to participate in CommunicAsia in Singapore last June.
- APIA supported MyNOG 2 in Malaysia last December
- APIA supported SANOG 21 was held in Cox's Bazar, Bangladesh in Jan 2013
- APIA hosted the APStar meeting on 24th Feb 2013 in Singapore. APIA will continue to support AP* Meetings in the future.

3.5 APRICOT

APRICOT 2013

Five (5) Workshops were held and concluded on 23 February 2013. Workshops remain a popular component of APRICOT. All sessions were filled and closed weeks before workshops commenced. Instructors comprise volunteers from the Industry.

Overall, seven hundred (700) delegates have registered for the Workshops, Conference & the APNIC members meeting. The Keynote speakers during the Opening plenary were Ms. Lynn StAmour & Mr. Fadi Chehadé. Mr. Tan Tin-Wee will present the closing keynote.

Singapore Network Information Centre (SGNIC) is hosting APRICOT 2013.

APRICOT 2014

The event will be jointly hosted by NECTEC & TRUE Corp in Thailand from 18th – 28th February 2014 at the Centara Grand & Bangkok Convention Centre, Bangkok.

APRICOT 2015

This event will be held jointly with APAN for the 2nd time and will be hosted by the Internet Community in Japan from 24^{th} February – 6^{th} March 2015 in Fukuoka, Japan .

Regular Meetings & Structure

Regular meetings are held by the following:

- APIA Board Every second Tuesday of the month
- APRICOT Management Committee Every first Tuesday of the month, increasing to fortnightly & then weekly closer to APRICOT
- APRICOT Programme Committee Every Wednesday during the development phase until the programme is mostly filled.

APIA Board oversees the activities of the three (3) APRICOT committees

APNIC

APIA Board meets regularly with the APNIC Executive Council to keep each other updated on respective organization's activities. The relationship is even closer now with APNIC taking on the Secretariat role for APIA.

Dr. Philip Smith concluded the Annual Report and open to the floor for questions.

As there were none, the motion to accept the Annual Report was proposed by Mr. Randy Whitney and seconded by Mr. Kurtis Lindqvist.

Dr. Smith then invited Treasurer, Mr. Gaurab Raj Upadhaya to present the Financial Report for 2012 and APIA's Budget for year 2013.

4. FINANCIAL REPORT 2012

Treasurer, Mr. Gaurab Raj Upadhaya highlighted the following in the financial report:

Balance Sheet

- During the year, APIA operated its SGD Account for its day to day operations
- All Time Deposits were maintained in the Euro Currency
- Accounts Payable in year 2012 represented hosting fee and sponsorship collected for APRICOT 2013
- Other Current Liabilities include Membership Fees for year 2013 collected in year 2012 & miscellaneous expenses to be paid

Statement of Income & Expenditure

- APIA made a surplus of USD4,878 in the year 2012
- Major item contributing to the surplus is the rise of the Euro against the USD
- Contribution Income comprises funding from ISOC & NSRC for the Fellowship Program

At the end of the Financial report, Mr. Upadhaya invited questions from the membership. As there were none, he proceeded to present the budget for APRICOT 2013.



5. APIA BUDGET FOR YEAR 2013

Mr. Gaurab Upadhaya highlighted to the members that:

- The Budget takes into account that the fee for APNIC's premium membership will be waived as part of the new MoU
- On the other hand, there will also not be any fees payable to the Secretariat
- Overall, APIA is expected to operate with a surplus in year 2013

As there were no questions on the budget, it was adopted as proposed by Mr. Randy Whitney and seconded by Mr. Kurtis Lindqvist.

Mr. Upadhaya concluded his Financial reporting and handed the floor back to the Chair to continue with the AGM.

6. ELECTION OF BOARD OF DIRECTORS

Dr. Philip Smith reported to the Meeting that the following persons were nominated for the election of Board of Directors.

As there was no contest, all nominees were elected to the APIA Board and will serve until the AGM in 2015.
